- 4. Should either university wish to terminate this Agreement, written notice should be given three months in advance of the desired termination date.
- 5. Only the English version of this Agreement has binding effect.
- 6. This Agreement will enter into effect from the date signed by the duly designated officials of the respective universities. The effective period is 5 years and renewable for a further term subject to the mutual written agreement of the parties.
